- 1) This contest is open to all interested in photography.
- 2) All the submitted photos must be taken at Kuching Buddhist Society Buddhist Village during 1 April 2013 till 27 April 2013.
- 3) Participants are allowed to send in as many entries as they wish and each entry must be attached with the entry form at the back of the photo, and the softcopy are required to save in the cd with minimum size not less than 4MB, but participants must maintain the originality of the softcopy. Photocopy of entry form is acceptable.
- 4) Each winner is eligible to win one prize only.
- 5) Submission fee is RM30.00 per set (3 photos) for non-member, and SPAS official member submission fee is RM20 per set (3 photos). Another RM5 is charge for every additional set (3 photos) of photos submission.
- 6) All cost incurred by the participants in this event will be borne by the participants. The organisers shall not be responsible for any damage or lost due to whatever cause to all entries submitted.
- 7) All photo submitted must be in 8R (8"x12")size. The entry that does not follow or abide to the terms and conditions shall be disqualified.
- 8) Photo submitted are non-returnable and will become the property of the organiser. The organiser can utilise, publish, display and broadcast all the photos for any purposes without prior notification or payment to the participants.
- 9) All entries must be submitted by 3pm on the 4 May 2013.
- 10) Result will be announced at major newspaper and the winner will be notified via telephone for prize presentation.
